The Ballot Paper should be returned in the sealed self-addressed envelope marked "**MWA BALLOT PAPER**" (provided for the purpose) to reach the Honorary Secretary General **not later than 12:00 NOON, 19 APRIL 2019.**

Ballot Paper shall be considered invalid if it contains one or more of the followings:

- More "X" entries than the number of vacancies for each post
- Any alterations or cancellations
- Name, signature, writings or other markings

Biodata of candidates are attached for your information and easy reference.

You are kindly reminded that in accordance with Clause 4 (5)(d) of the Constitution, no member shall be entitled to attend, speak or vote either in person or by proxy at any meeting of Association unless all monies (whether subscription or otherwise) then due from him to the Association have been paid.
