Environmental Issues with Water and Wastewater

When the current Environmental Quality Act was enacted in 1974, Malaysia's environment was in a significantly better shape. Air and water pollution were yet endemic and the nation's marine environments were in much better health.

Today, problems relating to the environment are becoming more complex. Environmental issues ought not to be taken lightly as the DOE together with the Malaysian courts are committed to enforce the EQA. Note that where an offence against the EQA or Regulation has been committed by a company, the CEO and company directors may be deemed to be guilty of that offence and risk being put in jail.

Is your organization being visited by DOE (Jabatan Alam Sekitar)? Do you wonder why some companies are caught and being exposed in the news for illegally disposing their production waste? Are you aware of the latest environmental laws such as Environmental Quality (Sewage) Regulations 2009 and Environmental Quality(Industrial Effluent) Regulations 2009?

A problem with water pollution is this: those who actively engage in polluting Malaysia's water sources can routinely do so with impunity. Why?
