Please read the terms and conditions below before proceeding with the booking:

- 4. For bookings received on or before 13 May 2025, if no payment is remitted after **7 days** from the issuance of the invoice, we will cancel your registration unless a **Letter of Undertaking (LOU)** is provided to secure your booking and payment.
- 5. Subject to full payment of the registration fees, substitutions are acceptable if you notify the organizer in writing by 6 May 2025 (two weeks before the event). An administrative fee of RM100.00 will apply to substitution requests received after this date. We will handle all cancellation requests on a discretionary basis.
- 6. All cancellation requests shall adhere to the following timeline and terms:
  - (i) Any requests for registration cancellation must be submitted in writing to the secretariat at caroline@mwa.org.my.
  - (ii) We will refund 50% of the registration fee if we receive the cancellation request on or before 6 May 2025.
  - (iii) We will not issue a refund if we receive the cancellation request after 6 May 2025, or if there is no show.
  - (iv) Within one month of the event, we will process all refund requests made before 6 May 2025 and impose penalty charges of RM200.00.
