- NOTICE OF 34th ANNUAL GENERAL MEETING**

In accordance with Clause 7 (1)(a) of the Malaysian Water Association (MWA) Constitution, notice is hereby given that the 34th Annual General Meeting (AGM) of the Malaysian Water Association will be held on date, time and venue as the following:

Date : **23 April 2021 (Saturday)**
Time : **10:00 am – 12:00 noon**
Medium : **Zoom platform**

The 34th AGM will be conducted via hybrid i.e. the meeting will be performed at the MWA premise in Taman Sri Hartamas, Kuala Lumpur attended onsite by the Council Members while other MWA Members will participate in the meeting via Zoom platform (online). The link for the meeting will be provided to members upon their registration.

The tentative Agenda for the meeting is as follows (the confirmed agenda will be circulated in the Annual Report):

2. Confirmation of the Minutes of 33rd AGM held on 24 April 2021
3. Matters Arising
4. Annual Report of the Council for 2021 / 2022
 - Report by the Hon. Secretary General on Activities
 - Report by the Hon. Treasurer General on Accounts
5. Any Other Business
(Of which notice shall have been given to the Hon. Secretary General seven (7) days before the AGM is due i.e. 15 April 2022)

All members of the Association are entitled to attend and to participate in the proceedings at the AGM, but only Ordinary and Institutional Members are entitled to vote and be recognised for the purpose of determining whether a quorum is present. The vote of Institutional Members is to be exercised through its authorised representative.

According to Clause 4 (5)(a) & (b), votes may be given either personally or by proxy. A proxy shall be appointed in writing under the hand of the appointer. A member may appoint another member as his proxy to represent him at any Annual General Meeting or adjourned Annual General Meeting and the proxy shall have all the rights and privileges of the member for whom he is representing and to vote thereat for himself and for the member for whom he is representing.

Under Clause 4 (5)(d) of the Constitution of the Association, members are not entitled to attend, speak or vote at the AGM unless monies due from them have been paid and these include the 2022 subscription fee.


Clause 7 (1)(e) states that the quorum for the AGM shall be one half of the total number of voting members or twice the number of the Council Members, whichever is the lesser. As the present Council has 20 members, this means a minimum of 40 members must be present in order to have a quorum. Your attendance at the AGM is very much appreciated.
